Dear members,

Further to my communication dated September 12, 2016, advising our members of CN's allegations of CNTL Calgary Owner-Operators defying Article 4.1 of the Unifor-CNTL Collective Agreement, and Sections 88.1 and 89 of the Canada Labour Code (the "Code"), all of which prohibit strikes during the term of a collective agreement.

Despite many members who showed themselves unavailable for work on September 11 and 12 making themselves available for work on September 12 (following our requests to do so), additional members booked off again on September 13th. Based on these actions, CN filed an application to the Canada Industrial Relations Board (CIRB) against Unifor for a '**Declaration of Illegal Strike**' and an '**Order to Cease and Desist**' pursuant to Sections 89 and 91 of the Code. Following CN's application to the CIRB (the "Board"), the Board conducted a hearing by teleconference at 16:00 MDT on September 13 between the Union, legal counsel and senior management of CN and officers of the Board - the Regional Director and Chairperson of the CIRB. Representing the Union on this call was Unifor Lawyer and Director of Unifor's Legal Department Anthony Dale, National Representative Bob Fitzgerald and myself. Following our 21-minute call, the Board issued, in part, the following Order:

That all Owner-Operators of the CNTL Calgary facility who are represented by Unifor National Council 4000 **cease and desist** from participating in any activities that constitute a strike as defined in Section 3(1) of the Code, and that all Owner-Operators of the CNTL Calgary facility are to **immediately report** for work and resume or continue to perform their regular duties in the normal manner.

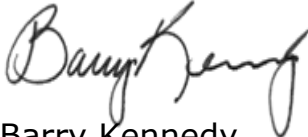
The Board also ordered us (the Union) to take immediate steps to communicate their Order to our CNTL Calgary membership affected by the Order, hence the reason for this letter.

Accordingly, the Union asks that any members who may still be showing as unavailable for work, **please make immediate arrangements to make yourself available for service**. Failing to do so, members will likely be deemed to be defying the Board's Order and thus participating in strike action as defined in Section 3(1) of the Canada Labour Code. Such members will face serious consequences, including disciplinary sanctions up to and including the termination of the member's standard contract with CNTL.

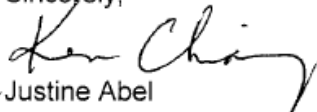
Dear Madam/Sir:

Order No. 876-NB

IN THE MATTER OF THE

Canada Labour Code

Canadian National Transportation Limited,

applicant,

Unifor National Council 4000,

WHEREAS the Owner-Operators of Canadian National Transportation Limited (CNTL or the employer) are represented by Unifor National Council 4000 (Unifor 4000) and CNTL and Unifor 4000 are parties to a collective agreement which expires March 31, 2019;

AND WHEREAS the Canada Industrial Relations Board (the Board) has received an application from the employer pursuant to sections 89 and 91 of the *Canada Labour Code (Part I—Industrial Relations)* (the *Code*) alleging that members of the bargaining unit represented by the respondent trade union have engaged in an unlawful strike, in contravention of section 89 of the *Code*, and seeking specific orders in relation thereto;

AND WHEREAS section 3(1) of the *Code* provides that a strike includes a cessation of work or a refusal to work or to continue to work by employees, in combination, in concert or in accordance with a common understanding, and a slowdown of work or other concerted activity on the part of the employees in relation to their work that is designed to restrict or limit output;

AND WHEREAS, the Board heard oral submissions from the parties by teleconference with respect to the employer's application on September 13, 2016;

AND WHEREAS, the Board finds that certain members of the bargaining unit represented by the respondent and assigned to the employer's Calgary facility did engage in activity that constitutes an unlawful strike on September 11, 12 and 13, 2016 in contravention of section 89(2) of the *Code*;

Order No. 876-NB

NOW THEREFORE, it is hereby ordered by the Canada Industrial Relations Board, pursuant to section 91 of the *Canada Labour Code (Part I-Industrial Relations)*, that:

- (i) The Owner-Operators of the CNTL Calgary facility who are represented by the respondent trade union cease and desist from participating in any activities that constitute a strike as defined in section 3(1) of the *Code*; and
- (ii) The Owner-Operators of the CNTL Calgary facility are to immediately report for work and resume or continue to perform their regular duties in the normal manner; and
- (iii) The trade union and the employer shall take immediate steps to communicate the Board's Order to the Owner-Operators affected by the Order.

THIS ORDER is made pursuant to the provisions of section 91 of the *Code* and shall remain in effect until the requirements of section 89(1) of the *Code* have been met, unless it is modified or revoked pursuant to an application under Section 93 of the *Code*.
