The Election Committee has declared a runoff election for your Regional Representative. Voting will open by online ballot on **Saturday, June 2, 2018** and will close on **Saturday, June 9, 2018 at 23:59** (Eastern Daylight Time).

If any member does not receive their voting credentials from Simply Voting, **please ask them to check their email spam, junk &/or trash folders carefully first*** for an email from Simply Voting. Please note the following steps need to be completed in order for them to receive their voting credentials.**

Since time is of the essence, the member must send the following 5 pieces of information

BY EMAIL ONLY NO LATER THAN 18:00 EST, JUNE 7, 2018 to. jacicarson@rogers.com

Name, complete civic address, Company, PIN AND Bargaining Unit. All 5 items must be included in their email. in order for them to receive their voting credentials in time from Simply Voting.

It should go without saying, but the Member should advise the NEC that they are looking for their voting credentials in the Subject Line. Do not send any information without advising that you have not received your voting credentials. **The NEC will not be able to process any emails received after 18:00 on June 7, 2018.**

If you previously sent an email after the deadline of May 24, 2018, please resend as it was not processed.

Please also distribute to all 5.1, 5.1 S & TTR members of Local 4003. It is the responsibility of the Local Chairs to ensure that the documents are distributed, posted, forwarded &/or sent. It is **not** the responsibility of the NEC.

Please let your fellow members know the following:

1. If the member received an email from Simply Voting during the election that ended May 25, 2018, they are already on the list.
2. If any member sent an email asking to be put on the voters list after the May 24 deadline, they are not on the list & will have to resend their same email or a new one.
3. Simply Voting will not be sending out their email until the morning of voting which is Sat Jun 2.
4. If a member did not/has not given their email address, they will be receiving the same letter as attached via Royal Mail, hopefully by Fri Jun 1.
5. If someone does not receive their letter by Royal Mail and they have kept their letter from the election ended May 25, 2018, they can use their same PIN & Voter ID to cast their vote after the election opens on Jun 2.
6. The election does not end until June 9, so that all members who wish to vote will have an opportunity to do so.

It's important for you to know that the list of voters is created from the employee lists supplied to Unifor Council 4000 by the companies. If a member does not know, has not been told or has chosen not to update any change to their address with the company, then Unifor Council 4000 **will not have their correct contact info.** Some have assumed that because they once gave their email address in an online election, that the Union should have their email address. We do not. The NEC is given the members information that is held by the company. Some members chose to "unsubscribe" in previous elections so their email address was not on file. Believe me, there is a myriad of issues that need to be dealt with regarding member lists for voting purposes.

Finally, please know that the NEC for this election was made up of 3 members who both hold & work at full-time positions. The Unifor Local 4003 run-off is being handled by me alone.
